Highlights from the first three years of Scotland's devolved tax authority



A note from the Chair _____



Revenue Scotland has completed its third operational year and successfully reached the end of its first corporate planning period as Scotland's tax authority.

The total tax revenue collected and transferred from Revenue Scotland to the Scottish Consolidated Fund since our operations began has now reached £1.8bn.

This is significant financial support for public services across Scotland and highlights the importance of

devolved taxes. During 2017-18 the revenue raised from Land and Buildings Transaction Tax (LBTT) and Scottish Landfill Tax (SLfT) was £707m, an increase of 11.7% on the £633m raised the previous year.

The number of tax returns submitted online also increased in 2017-18 – from 98.8% in 2016-17 to 99.1%.

We continue to engage with and inform taxpayers and stakeholders through a range of activities including technical tax events, our professional operational support team and by updating and maintaining our online tax guidance.

Revenue Scotland has also focused on compliance work, increasing tax revenue in 2017-18 to £2.4m. And we continue to ensure we can provide efficient and effective services, with operational costs in 2017-18 at only 0.78% of the total tax revenue.


