Logging on to the new SETS requires 2 steps:

- 1. Activating your account
- 2. Logging on to the new portal

1. Activating your account

The first time you log in to the upgraded system, you will need to activate your account. This involves:

- 1. resetting your password, then
- 2. receiving an email with instructions, then
- 3. clicking the link in the email to activate your account

1. Reset your password

Select 'Forgotten your Password' and follow the prompts, as below.

- when at the account activation page, copy and paste the registration token into the 'Token' field.)

-Please ensure when copying your registration token, you are only copying the registration token and not picking up an extra space at the end of the token. If a space is included, the token will not be recognised by the system and users will not be able to login.

Users must activate their account in SETS before trying to log on. Only once the account is activated your users then trying logging on to the portal.

2. How to login to SETS – business as usual

** If this is your first time entering the new SETS, you will first have to activate your account before trying to log in to the portal. (See Step 1 'Activate your Account' above). **

1. Enter your Username and Password, this will then generate an email with an authentication token.

Remember to use the new password that you would have reset as part of the account activation process.

The authentication token is part of our Two Factor Authentication process - previously known as a One Time Passcode (OTP).

2. Check your Inbox for an email from Revenue Scotland with the authentication token.

The email and authentication token will look like below :



3. Return to the portal and sign in, using your Username and the newly received authentication token, as below:
