How We Use Your Information

The Scottish Environment Protection Agency (SEPA) will be the data controller of the information you provide in this form.

SEPA was established under the Environment Act 1995 and is responsible for protecting and improving the environment. SEPA also has functions relating to Scottish Landfill Tax and is the regulator of the Scottish Landfill Communities Fund (the "Fund").

The information provided in this form will be processed by SEPA to monitor compliance with your obligations as an Approved Body, maintain the published register of Approved Bodies, collate and publish SLCF statistics and in otherwise discharging SEPA's regulatory obligations under the Regulations.

SEPA may also use your information:

- in exercising its other functions and powers in connection with the Scottish Landfill Tax, protecting and improving the environment;
- to offer/provide you with literature/services and guidance relating to the Fund, the Scottish Landfill Tax and other environmental affairs;
- to carry out statistical analysis, research and development on environmental and Scottish Landfill Tax issues; to provide published information to enquirers;
- to investigate possible breaches of environmental and Scottish Landfill Tax law and taking any resulting action;
- to prevent breaches of environmental and Scottish Landfill Tax law;
- for the purposes of public consultations; or
- to assess customer service satisfaction and improve our service.

We may also share your information with (and obtain information about you from) public bodies such as Revenue Scotland, the Scottish Government, the Police, HMRC, ENTRUST, the Health & Safety Executive, local authorities and the emergency services, and organisations and agents that act for them. Any such data sharing will be for various purposes, such as making sure the information is accurate, to prevent or detect crime, to protect public funds and enabling the relevant public bodies to perform their statutory functions.

You should ensure that any persons named on this form are informed of the contents of this notice.

Notes

Requirement to notify

Regulation 30 (1) (g) of the Scottish Landfill Tax (Administration) Regulations 2015 requires you to notify SEPA within seven days of any transfer of qualifying contributions or income from you. This form should be used to notify us of any transfers of money to a project. Regulation 30(1) (n) requires you to also notify the landfill operator and any contributing third party that you have transferred their contribution to a project.

Transfer of monies from one Approved Body to another Approved Body or from an Approved Body back to a landfill operator should be notified to SEPA using a Transfer of Monies form (<u>https://www.revenue.scot/scottish-landfill-communities-fund/approved-bodies</u>). This form, and certain details from the project enrolment form and the contributing third party form, sets out the statutory information that an Approved Body is required to provide to SEPA. Failure to provide this information by the statutory deadline may result in enforcement action being taken.

Approved Body Details

1 Enter the name and SLCF registration number of your Approved Body so that SEPA can identify you.

Project Details

- 2 Enter the project name and enrolment number so that SEPA can identify the project. The enrolment number is the number you assigned to the project and notified to SEPA on the Project Enrolment form. You can only transfer SLCF monies to projects that are already enrolled.
- 3 Enter the enrolment date. This was notified to SEPA in the project enrolment form.
- 4 Enter the date the money was transferred to the project. Do not notify SEPA about future transfers that have not been made yet. Only notify SEPA of transfers that have taken place.
- 5 Enter the amount of SLCF money that was transferred to the project in this transaction.

Qualifying Contribution Details

- 6 List all of the qualifying contributions that are being used in this transaction. You may be using money from more than one qualifying contribution. For each QC being used tell SEPA the name of the landfill operator that contributed it, the SLfT registration number of the contributor, the date you received the QC, the amount received and the amount from that QC being transferred to the project.
- 7 Tick to indicate if you have notified the contributing landfill operator(s) of the transfer of their funds. If you tick no be sure to notify them as soon as possible.

Contributing Third Party (CTP) information

8-10 Please confirm whether there are any CTP payments associated with the QCs being used in this transaction.

If you haven't already notified SEPA of the CTP details, please submit a CTP form. You must also notify the CTP of the transfer.
